We are awaiting our fictitious tax business name and once it's filed, it has to be posted for a certain amount of days before we can use it to get a new bank account. We used a CPA, and with all of the filings that we had to do, it's probably going to cost us about \$500. The business address for the CPA will be where our tax fillings go to and the Treasurer is responsible for making sure that those filings are done.

 - Steve C. reports that we spoke to our insurance person who now has a full understanding of what our needs are. We got an update from the Unity committee about their planned events. We also have the updated schedule from the Secretary, so we're going to be looking at a blanket policy

that will cover all of our meetings and events. (Not every meeting needs one.) We should have it resolved by the Halloween party or the next GSO.

- Election positions and requirements: Melanie R.G. reports on the open positions:

-Nick B.-

Executive Board Positions:

- <u>Chairperson</u>: Frank P. has served two years and steps down in December. For that position, you need two years of sobriety, two years previous GSO experience and preferably have been vice chair or and at least on the executive board.
- <u>Vice chairperson</u>: Nick B. is also completing his two-year term in December. For that position, you need two years sobriety, one year previous GSO experience and ability to act as Chair.
- <u>Secretary:</u> Melanie R.G. will be completing her two-year term. For that position, you need one year of sobriety and six months of previous GSO experience.
- <u>Treasurer:</u> Betsy L. has completed one year of her two-year term so she will be completing her term in December 2025 and that position is therefore not open, which is a good thing for continuity.
- <u>Vice treasurer:</u> Donovan B. has completed one year of his two-year term so he will be completing his term in December 2025 and that position is therefore not open.
- <u>S&B Chair</u>: Steve C. has served for three years. It's a two-year term. The requirements for that position are three years sobriety, one year previous Executive Board experience, and preferably vice chair and or executive board person.
- <u>Archive Chair:</u> Alonzo M. has completed one year of his two-year term so he will be completing his term in December 2025 and that position is therefore not open.

GSO Committee Chairs:

All of the committees have a one year term for chairs, with the exception of Unity and PI that have two. Thus, the following positions are up for elections:

- **<u>GRC Committee Chair</u>**: This is the advisory role that Dan S. has right now. That position must be filled by a delegate or alternate delegate.
- IT Committee Chair: up for reelection, one year sobriety required.
- <u>Unity Committee Chair:</u> Neelam A. is finishing out Dreia M.'s term, so that that position is also up for election. For that position, you need two years of sobriety and six months of GSO experience.
- **<u>Chip Committee Chair:</u>** up for reelection, one year sobriety required.
- Literature Committee Chair: up for reelection, one year sobriety required.
- <u>PI Committee Chair:</u> Jose A. started in January of 2024, so he has one more year to go, so that position is not open.
- <u>H&I Committee Chair:</u> up for reelection, one year sobriety required.
- <u>Workshop Committee Chair:</u> one year of sobriety required in addition to training under Nick B. on how to run the 4th Step Workshop.

Delegate and Alternate Delegate Positions:

- Dan S. is going to be an outgoing delegate in December, so that position will be open. Requirement is four years of sobriety and GSO experience. Nolan O. and Steve C. still have through the end of their term in December 2025.
- Alternate delegates, Melanie R.G. and Liz M. need to be ratified for two more years. Alternate delegates requirement is two-year sobriety and GSO experience.

\Rightarrow <u>Vice-Treasurer's Report</u>

- 949.910.0901 -Donovan B.-Report: Donovan B. reiterates our nonprofit status has been reinstated. He points to the fact that we want to do big events, but our accounts are down \$ 1,000 in our savings and we need to recuperate that. We made only \$100 dollars last month and he is noticing that we are collecting either very little money from some meetings or none at all. We are already in October and all year long we have seen for example the "Chore Boy's Meeting", and "Upstairs Downstairs" have donated \$0, \$5 from "Live Free", \$20 from "The Madd Realm, as an example. Donovan B. states that if we want to have big events we have to go back to our meetings and put it out there that we need funds.
 - Discussion: Neelam A. explains that the big event of the "Gratitude Banquet" scheduled tentatively for early next year would be an opportunity to bring the fellowship together in a black-tie event and our nonprofit status gives us some discounts for the venue, catering, etc. The plan is to create opportunities such as an auction of major items to fundraise. About 123 people. While newcomers are often strapped for money, Donovan B. believes they can contribute something. Jessica M. says the people at treatment centers are not allowed to carry any money on them. Melanie R.G. reiterates that we have three events coming up and getting people there will help bring in funds.

Matt A. makes a motion to change the wording to article 10, section four, subsection Roman numeral one from "nominations for chairperson positions shall be held at the GSO meeting in the month of November" to read "nominations for committee chairpersons shall be announced in October and November. Nominations for these positions shall be held in December." Seconded. Passes unanimously.

- Nick B. explains the vote on elections timeline was done in two motions because they are in two different sections of the S&B's, one for the Executive Board and another for the Committee Chairs.
- Matt A. presents the finished OCCA service manual. We have been hard at work on this for a while, about 40 pages, and is essentially a guide for anyone new to service at the area level. Matt A. passes it around so people can see it and it was also emailed to all. The Executive Board has approved it to come for a vote at the GSO.

Matt A. makes a motion to approve the OCCA Service Manual. Seconded.

Nick B. expresses that he thinks it is best to give all the opportunity to read through it and vote next months.

Nick B. makes a motion to table to next month. Seconded. Passes unanimously.

Discussion: if you have changes or corrections, you can join the meeting, like Angel G. did for social media, or you could make a referral and have S&B committee do all the work. - Report: Jenn C. reports for Jose A. saying on October 12th they will have the "Anonymous Pedalers event" where they will be biking along a route, and she has a flyer.
- Jenn C. reports that they are also planning a "Grateful, thankful and fed" event on November 16-17 and are checking city ordinances, location TBD. December 12, we have the cozy Christmas goody bags to include gloves, socks, blankets, etc. PI is also making another video off of a pamphlet.
- Both the Thanksgiving meals and the goody bags are being done by the group individually with the hope of reaching people in active addiction to let them know we are here for them.
- ⇒ Social Media Subcommittee Report: -Angel G.-Report: Angel G. reports that for the month of September, we had a total of 5,119 views on our social media. 47% of that were followers, 52 were not. Our top reels for this month were the "God Shot Card Draw" with 184, "Madd Realm" with 257, "Anonymous Pedalers" was 259 and the "Back to Basics Mini Marathon" with 600. The ad that we're boosting has a total of 5,764 views, 25 interactions. Somebody's been sending it out to somebody else and it lands on somebody's algorithm, and it sends them right to our page. We've spent \$18.19 of the requested \$30.
 - Angel G. requests that flyers be sent to him for posting or if you need help creating flyers, he is using Al for many of them, so all the people are not real. At this time, there is no more need for funds to boost.
 - Melanie R.G. says that for those who are not on social media, if you go to the website and press the • buttons on the right side for Facebook and Instagram it will take you to our active pages.

These positions could help coordinate so that it does not fall on a just a few people and avoid burnout.
- Nolan O. reports on the Halloween Party at Barn Life, a great property, on October 27th, 5-9, we need volunteers to help, donations of \$5-\$10 are being asked for the food. (Spaghetti dinner with salad and bread). Costume contest, desert contest and mystery box contest ending in a speaker meeting. There is a request for a donation of \$25 from each meeting to help offset expenses. He has \$ 225 donated already found an additional \$100 from an individual and Kim gets the treatment centers that she invites to donate money for their clients to attend. We have been asked to put in a damage deposit of \$500 and it's refundable. We have use of the whole property with bathrooms, no porta potty needed. Nolan O. is trying to not have to ask for funds from OCCA as we are low in funds right now.

Since OCCA has been unable to secure insurance yet we can purchase it through them for \$75 for \$500,000.

• Neelam A. reports that the Turkey Bowl will be November 9th at Irvine Lanes from 7:30 to 9. Chris J. passed around the flyers. We have four lanes for six people each. GSR's are encouraged to announce the event and have people reserve their spot by presale and they can collect the money.

• Neelam A. makes a motion to request \$ 50 to reimburse Chris J. for the deposit on the bowling alley. Seconded.

• Neelam A. responds to a question that the cost of the event is \$500, and we are hoping to recuperate all that. A small poll at the H&I meeting already showed 8 people going. Chris J. corrects the event to be \$520. Donovan B. has concerns about the next request as after we pay this \$50, we will be left with \$100 in our accounts. Chris J. speaks in favor by saying that the presale will give us an idea of how many lanes we will need. GSR's can collect the money, and send it to Chris J. via Zelle, Venmo, cash or check.

• Motion passes with substantial unanimity.

- Neelam A. makes a motion requesting \$520 to cover the cost of the bowling lanes for Irvine Lanes. Seconded.
- Nolan O. speaks in favor as he believes that by the end of the event we will break even if not turn in a small profit.

• Motion passes unanimously.

• Neelam A. says that maybe we can organize something for Christmas to give comfort to those far from home and maybe team up with PI to do something together.

- The motion now reads as requesting funds in the amount of \$ 647.58 for literature. •
- Debate: Frank P. is grateful that Dan S. can pick up the order, but he raises the point that, in his role of being fiscally responsible, he needs to raise the issue that if, for example, the literature gets stolen out of Dan S.' car, who is responsible. In the past, Mathew M. and Carlo P. would be the ones driving to the office to pick up literature and chips. He adds that using the prudent reserve to stock up on books could be a good thing because the money will come back to us. Frank P. says that any money coming in today should be taken care of while the treasury is open and deposited to the bank as soon as possible. Dan S. takes full responsibility for the books as a service to C.A.
